

## • Livingston Growth Policy: Great progress!

The Livingston Planning Board has made great strides in transforming a very ordinary, sprawl-accepting growth policy into a strong statement in favor of compact, traditional pattern of development and the protection of the farmlands, ranch lands and wildlife habitat around the city from rural sprawl. Friends of Park County has played a crucial role in assisting the Board by providing specific recommendations backed by data and information. information packet] and then it is on to the City Commission for its review. And then comes the next hard assignment – implementation.

Curbing sprawl in rural Park County: No progress with County government.
 Friends of Park County, other community organizations and especially
 County residents will need to fill the rural sprawl leadership vacuum.


In January Friends of Park County and its supporters presented <u>testimony to the County</u> <u>Planning Board about the risks and impacts of rural sprawl</u>. At the end of the public comments, the Planning Board voted to request staff to bring forth information about rural sprawl for future County Planning Board discussion. So it was disappointing when at the March meeting the Planning Director and Planning Board Chair made it very clear that they do not regard rural sprawl as a threat to Park County, either because they believe it is not happening and will not happen or because they actually welcome this kind of development. Instead of addressing rural sprawl, the County continues to focus on the permit-processing ordinance the staff began working on in November 2019. To fill the leadership vacuum on rural sprawl, Friends of Park County is working alongside others to organize presentations and discussions about different options for curbing sprawl.

For those of you who want more details, the following is a first of a two-part detailed update that will focus on the revisions to the City of Livingston's Growth Policy Draft review. Part two of our detailed update will deal with the Park County's Planning Board struggle to meaningfully deal with rural residential sprawl and development of a planning strategy for smart growth.

## **Livingston Growth Policy: Great Progress!**

The Livingston Planning Board has been working very long hours (four-hour meetings!) reviewing and revising the city's draft Growth Policy. They have taken long strides toward a serious commitment to compact growth based on traditional neighborhood design and to stopping sprawl around the city. At every meeting Friends of Park County has *proposed specific language and offered supporting information for new and better policies* to reinforce this compact, Smart Growth re-orientation.

FPC used some simple calculations to show that **the city already had more than enough land available inside the city limits to accommodate new housing for 20 years** or more.

Perhaps the most dramatic shift has been the Planning Board's decision to replace the proposed land use designation allowing ½ acre and 1 acre lots across thousands of acres outside the city limits with the designation of that land for pastoral and open space. That followed FPC's testimony that the proposed city land use designation would have allowed up to 26,000 new homes, enough for 59,000 people -in the rural areas outside Livingston city limits.

FPC's positions on many of the biggest issues have been echoed by other people and organizations. Overall, the level of public engagement has been high and of high quality and that is making a big difference.

Wednesday April 7 is the final Planning Board meeting to consider revisions to the draft Growth Policy. (Meeting information can be found <a href="https://example.com/here">here</a>.) Friends of Park County will be contributing testimony on the Chapters related to Public Facilities, Inter-governmental Coordination and Implementation.

They expect to conclude their work on the draft Growth Policy on April 21 and send it on to the City Commission for its review and final action.

But a Growth Policy is, by law, only advisory. Almost as hard as preparing a strong Growth Policy is implementing that Growth Policy by revising and adopting appropriate land use regulations, by implementing policies governing annexations and the extension of city services and other means.
